This is an addendum to the original contract signed October 17, 2019. The purpose of this addendum is to provide Client a website refresh and required SEO, valued at **\$63,050**. Client and HS agree to the following Terms:

The initial term is to be extended by 24 months (January 2021 through December 2022). The Monthly payments for new branding and creative work will be added in the amount of \$5,255 per month for six (6) months beginning March 2020 in order to cover 50% of the total cost of the additional work, or \$31,525. The remaining 50% of the project costs shall be considered covered under the Monthly Marketing Partnership Program payments at a rate of \$1,125.89 per month over the remaining 28 months of Marketing Services Agreement Term. All other Terms included in the contract dated October 17, 2019 remain unchanged.
